The Story of
The Jana E. Pinker
Memorial Foundation

We miss Jana tremendously. She was in our lives for 19 years and she left us, as many people do, much too soon.

In May of 1997, Jana graduated from Olathe South High School, where she was a member of the Drill Team, National Honor Society, Chess Club, German Club, Swim Team and the Quest Program. After high school, Jana had big plans: She was going to attend Johnson County Community College (where her dad and mom still teach), earn her associate of arts degree, transfer to the University of Kansas, and pursue a degree in education. She wanted to teach genetics to high school students (her high school genetics teacher made a lasting impression). Jana was a member of Advent Lutheran Church, as well as the Kansas City St. Andrew's Society. She loved to travel, and at age 19 she had already been to Europe twice, Aruba and different parts of the United States. She could tell a joke like few other girls her age (she had a marvelously wicked sense of humor), and her smile truly did light up a room. She had beautiful long blonde hair, big blue eyes and a perpetual tan from many summers spent as a lifeguard at Oregon Trail Pool. The youngest of three children, Jana sometimes enjoyed being the baby of the family, and sometimes she despised it like the plague. Yes, we miss her tremendously.

In August of 1997, at 18, Jana was diagnosed with a rare form of liver cancer. At the MD Anderson Cancer Research Institute in Houston, Texas, she was told her illness was terminal – she would probably not survive another year. Jana fought her illness with every ounce of strength she had. She even completed a semester of college. Jana beat the odds – she lived 15 months after diagnosis. Jana Elizabeth Pinker passed away on November 23, 1998.

We, the Pinker family, created The Jana E. Pinker Memorial Foundation in April of 1999. The Foundation is registered with the State of Kansas as a nonprofit corporation and with the Internal Revenue Service as a 501(c)3 charity. The Foundation's mission statement is simple: To remember and honor our daughter and sister, Jana. You see, we know that we will never forget Jana. She will live within each of us forever, but we want Jana's memory and everything that she believed in to continue. We have already accomplished several of our initial objectives. These objectives include establishing scholarships at the high school and college level, making contributions to various charitable organizations and performing arts programs in our community, such as Habitat for Humanity, the Kansas City Ballet, and Kansas City Friends of Chamber Music. Through the Foundation we keep the memory of Jana alive.

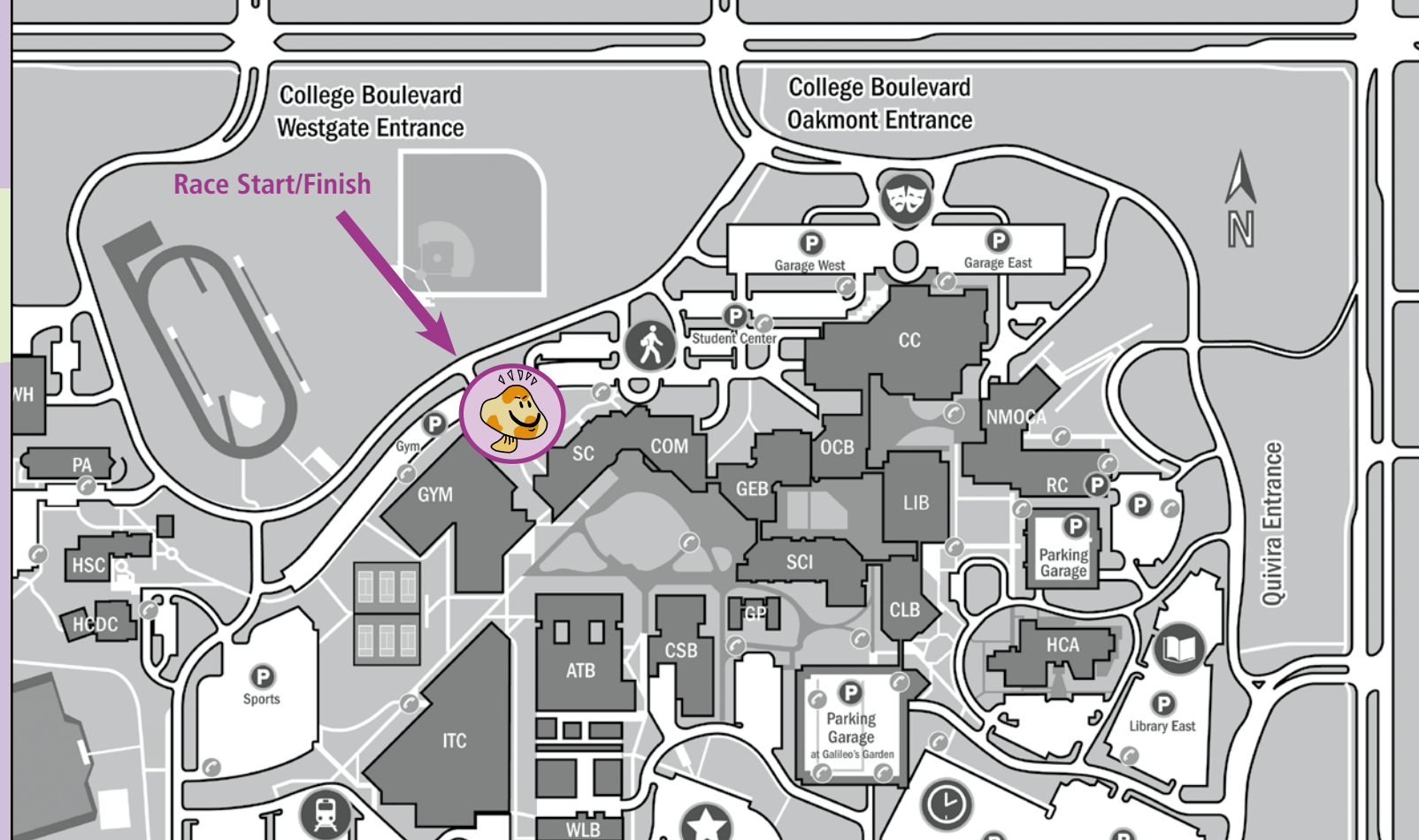
Awards will be given to the top male and female finishers in the following age categories:

Runner Protection and Aid

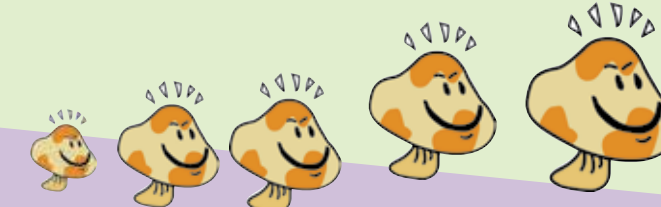
Baby strollers, baby joggers, roller skates, roller blades, hand/foot cycles and dogs are not allowed on the course.
